ITEM #1 MEETING CALLED TO ORDER

County Judge James Barden called the meeting to order at 9:00 a.m. and noted that all members were present with the exception of Commissioner Keller. There was a quorum for business.

Other officials/department heads in attendance for all or part of the meeting were Tammy Cook for the County Treasurer, County Auditor Teresa Martinez, County Clerk Lisa Wernette, Sheriff Randy Brown and Administrative Assistant Jennifer Adlong.

ITEM #2 DISCUSS AND CONSIDER APPROVAL OF SEPTEMBER 10, 2007 MINUTES

Ben Walwer – Tomerlin Cemetery Mary Walpole – Quihi Evelyn Barbutti – Chamber of Commerce Gary Bartelt – VSD Tony VanDebur – Community EMS

Dolly Walwer spoke to the Court Members concerning the Tomerlin Cemetery. Mrs. Walwer advised the Court Members that Mr. Walwer and she had been maintaining the Tomerlin Cemetery for 43 years and now they find themselves in need of some help. Judge Barden advised Mrs. Walwer that the Court Members appreciated all the hard work over the years and that he would be happy to speak with them at a later time.

ITEM #8

DISCUSS AND CONSIDER APPROVAL OF MEDINA COUNTY 911 EMERGENCY COMMUNICATIONS DISTRICT 2007-2008 BUDGET (ROBERT ROTHE, EXECUTIVE DIRECTOR)

Robert Rothe reported to the Court Members the Medina County 911 Emergency Communications District 2007-2008 Budget. A motion was made by Commissioner Ulbrich second by Commissioner Barrientes to approve the 2007-2008 Budget of Medina County 911 Emergency Communications District. Motion carried.

ITEM #9 DISCUSS AND CONSIDER ADOPTION OF THE 2007 MEDINA COUNTY TAX RATE

Court Members opened discussion concerning the adoption of the 2007 Medina County tax rate. Judge Barden reported to the Court Members the \$.5750 per \$100 valuation is \$.05 less than the previous year. The County anticipates receiving additional revenue even with the tax reduction.

A motion was made by Commissioner Carroll as follows: "I move that property taxes be increased by the adoption of a tax rate of \$.5750". Motion was second by Commissioner Ulbrich. Motion carried. Judge Barden pointed out that while total tax revenue will increase the actual tax rate for 2007 is \$.05 less than the 2006 tax rate of \$.6250. The increase in tax revenue is attributable to significant new development in the county as well as increased values of existing properties.

DISCUSS AND CONSIDER COURTHOUSE PRESERVATION GRANT APPLICATION INCLUDING CONFIGURATION OF COURTHOUSE

Item #10 was tabled until a later date.

ITEM #11 DISCUSS AND CONSIDER RESOLUTION FOR THE 2008 INDIGENT DEFENSE GRANT PROGRAM

A motion was made by Commissioner Carroll second by Commissioner Ulbrich to authorize County Judge Jim Barden to apply for, accept, decline, modify or cancel the 2008 Indigent Defense Fund Grant as discussed. The motion carried.

ITEM #12

DISCUSS AND CONSIDER INTERLOCAL PARTICIPATION AGREEMENTS WITH TEXAS ASSOCIATION OF COUNTIES RISK MANAGEMENT POOL

Court Members opened discussion concerning the Interlocal Participation agreement with Texas Association of Counties Risk Management Pool. A motion was made by Commissioner Carroll second by Commissioner Ulbrich to approve Interlocal Participation Agreements with Texas Association of Counties Risk Management Pool. (See attached) Motion carried.

ITEM #13 DISCUSS AND CONSIDER PROPOSED LEASE AGREEMENT FOR ADDITIONAL OFFICE SPACE

Judge Barden opened discussion concerning the proposed additional office space for the County Auditor's office. The price is \$.95 per square foot with a total of 1120 square feet. This lease will be effective October 1, 2007 and the \$.95 per square foot will be effective for 3 years. In addition the County will pay a pro-rata portion (30%) of utility bills for the building. Also, there are two one-year options to extend the lease. This property is located at 1616 Ave. M, Hondo, TX, also known as Park Place.

A motion was made by Commissioner Carroll second by Commissioner Ulbrich to approve the proposed lease agreement for additional office space. Motion carried.

ITEM #14

DISCUSS AND CONSIDER AGREEMENT WITH SOUTH TEXAS REFUSE FOR OPERATION OF CITIZEN COLLECTION SITES

A motion was made by Commissioner Carroll second by Commissioner Ulbrich to approve the agreement with South Texas Refuse for operation of citizen collection sites including new prices of \$6500/month for all sites. The other contractual conditions are unchanged from the current agreement. Motion carried.

Judge Barden recommended an increase from 180% match to a proposed match of 200% on future deposits of employees and to provide a cost of living increase of 3% to already retired personnel with both changes to be effective January 1, 2008.

A motion was made by Commissioner Carroll second by Commissioner Ulbrich to approve the personnel policy manual updates to reflect wage increases of 5% effective in the first full payroll period in the fiscal year for FY 2007-2008. Motion carried.

DISCUSS AND CONSIDER APPROVAL OF THE PURCHASE OF ADDITIONAL VOTING EQUIPMENT FROM HART INTERCIVIC

County Clerk Lisa Wernette presented to the Court Members a proposal for additional election equipment at the cost of \$38,257.00. This election equipment can be upgraded to accommodate a paper trail. A motion was made by Commissioner Carroll second by Commissioner Ulbrich to approve the purchase of additional voting equipment from Hart Intercivic. Motion carried. (See attached)

CONTRACT FOR ASSESSMENT AND COLLECTION SERVICES

On this the 24 th day Argust, 2007, Medina County Emergency Services District No. 5- Natalia VFD ("the District") and Medina County entered into the following agreement whereby Medina County will collect the District's current and delinquent ad valorem taxes under the terms that follow below.

Pursuant to Section 776.075(e) of the Texas Health and Safety Code, the Medina County Tax Assessor-Collector ("the Tax Collector") is the designated Tax Assessor-Collector for the District.

Medina County will collect the current and delinquent taxes, penalty and interest owing to the District and will further perform all duties relating to the assessment and collection of taxes as provided by the laws of the State of Texas. The District will comply with all lawful and reasonable procedures that the Tax Collector establishes to clarify and expedite the collection of the District's taxes.

The Tax Collector will remit all taxes, penalty and interest that Medina County collects for the District bi-weekly. The District will pay the Tax Collector 1.5% of all taxes, penalty and interest collected on its behalf as a fee for the services provided. The Tax Collector will deduct the fees from its remittances to the District and will provide the District an accounting therefore. The parties agree that the fee is reasonable and does not exceed the costs of collection.

The District agrees to adopt its tax rate no later than September 24th, or by the date that Medina County sets its tax rate, whichever is later. If the District fails to adopt its tax rate at the appropriate time and it becomes necessary for Medina County to mail an additional statement for the District's taxes, such additional statement and mailing shall

be "extra work". The District agrees to pay the Tax Collector for such extra work, provided, however, that the Tax Collector shall notify the District in writing that it considers such service to be extra work and the proposed costs therefore, which will be deducted from the remittances along with the regular fees.

At the District's option and expense the District may obtain a surety bond for the Tax Collector. Such bond shall be payable to the District, and shall be in the amount of one year's collections, and in no event less than \$10,000.

Medina County will provide an attorney of its choosing to assist in the collection of delinquent taxes, penalty and interest. The District will use Medina County's attorney. The Tax Collector will deduct the contractual attorney fees from its remittances and will provide the District an accounting therefore. The District understands that the attorney fees are paid by the delinquent taxpayers.
