On the 21st day of August 2025, be it known that the Board of Emergency Services Commissioners of Medina County Emergency Services District No. 5 ("District") hereby adopted, by a majority vote of ______ in favor, ______ against, _____ present-not voting, and ______ absent, the District's ad valorem tax rate for the 2025 tax year as follows: A separately adopted Debt Rate of .0152 per \$100 valuation and a separately adopted Maintenance and Operation Rate of .0848 per \$100 valuation for a rate of \$0.10 per \$100.00 valuation of the appraised property within the boundaries of the District. Per the Texas Tax Code § 26.05, all taxes raised by said rate will be used to fund the maintenance, operations, and outstanding debt expenditures of the District for the next year in providing emergency services.

THIS TAX RATE WILL RAISE MORE IN TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

MEDINA COUNTY EMERGENCY SERVICES DISTRICT NO. 5 ADOPTED A TAX RATE THAT WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

THE TAX RATE WILL EFFECTIVELY BE RAISED BY 9.84 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$5.20.
