## ITEM #1 MEETING CALLED TO ORDER

County Judge James Barden called the meeting to order at 9:00 a.m. and stated that all court members were present with the exception of Commissioner Kelly Carroll who is absent due to illness.

Other officials/department heads in attendance for today's meeting were Sheriff Gilbert Rodriguez, County Treasurer Rita Moos, County Auditor Teresa Martinez and County Clerk Elva Miranda.

# ITEM #2 DISCUSS AND CONSIDER APPROVAL OF JULY 31, 2006 MINUTES

After review of the minutes, a motion was made by Commissioner Keller and second by Commissioner Barrientes to approve the minutes as written.

The motion carried. Commissioner Mitchell abstained due to her absence from that day's meeting.

#### ITEM #10

# DISCUSS AND CONSIDER FINAL APPROVAL TO J. ILTIS SUBDIVISION; LOCATED IN PRECINCT 1 OFF OF FM 2676, (PAUL CAREY, SURVEYOR)

Court members reviewed the proposed final plat which contains 2 lots. It was noted that the eastern portion of both lots are partially located in the flood hazard area.

After consideration, a motion was made by Commissioner Mitchell and second by Commissioner Keller to grant final approval to J. Iltis Subdivision. The motion carried unanimously.

## ITEM #11

# DISCUSS AND CONSIDER VACATING AND REPLATTING LOT 1 OF SHEPPARD HILL SUBDIVISION; LOCATED IN PRECINCT 3 OFF OF CR 662 AND PR 6621 (TIM HARDT, REALTOR)

Mr. Tim Hardt stated that the landowner is requesting to vacate Lot 1 which contains 19.77 acres and replat into Lot 1-A and 1-B. An existing well is located on Lot 1-A and Lot 1-B will also have its own water well. (See attachment)

After discussion, a motion was made by Commissioner Keller and second by Commissioner Barrientes to grant approval to the replat of Lot 1 into Lot 1-A and 1-B of Sheppard Hill Subdivision. The motion carried unanimously.

#### ITEM #12

# DISCUSS AND CONSIDER PRELIMINARY APPROVAL TO VACATING AND REPLATTING LOTS 112 AND 113 OF FAWN VALLEY SUBDIVISION; LOCATED IN PRECINCT 1 OFF OF CR 4638 (JOHN HOWARD, SURVEYOR)

Court members reviewed the proposed plat as submitted. Lot 112 presently consists of 1 acre, as well as, Lot 113. The proposed replat eliminates Lot 112 and increases Lot 113 to 1.647 acres. The remaining acreage is being reserved for a roadway.

After consideration, a motion was made by Commissioner Mitchell and second by Commissioner Keller to grant preliminary approval to vacating and replatting of Lots 112 and 113. The motion carried.

# DISCUSS AND CONSIDER PRELIMINARY AND FINAL APPROVAL TO (S.I.C. STEWART) STUART ADDITION SUBDIVISION; LOCATED IN PRECINCT 1 OFF OF FM 2676 (CHARLIE ROTHE, SURVEYOR)

Court members reviewed the proposed 1 lot subdivision plat which originated from larger acreage. The lot consists of 1.501 acres and has an existing structure with septic system, water and electric services.

## DISCUSS AND CONSIDER INCREASING DOLLAR AMOUNT AND NUMBER OF CHANGE DRAWERS IN JUSTICE OF THE PEACE PRECINCT 4 OFFICE

County Auditor Teresa Martinez informed court members that the Justice of the Peace Precinct 4 Office in Devine has been operating with only one (1) cash drawer. A request is being submitted for two (2) additional cash drawers with beginning cash of \$50.00 each, and increase the original cash drawers' beginning cash from \$42.50 to \$50.

After consideration, a motion was made by Commissioner Keller and second by Commissioner Mitchell to increase the number of cash drawers, as requested, in the Justice of the Peace Office, approve \$50 beginning cash for each drawer, and increase the original drawers' beginning cash to \$50. The motion was approved by a unanimous vote.

# DISCUSS AND CONSIDER APPROVAL OF ELECTION SERVICES CONTRACT BETWEEN MEDINA COUNTY AND DEVINE ISD

Judge Barden stated that Devine ISD and only a handful of other ISD's in the State conduct their trustee elections in November. Due to a new State mandate, any political subdivision that conducts elections in November are mandated to use the County's polling sites. Due to this mandate, a meeting between County Clerk Elva Miranda, Devine ISD Representative Marie Talamantes and himself had been held to discuss the possibility of Medina County conducting Devine ISD's trustee election by adding their issues on the November General Election ballot. He further stated that Ms. Miranda is willing to conduct their election, and a preliminary agreement was reached.



# ITEM #17 ELECTION SERVICES CONTRACT - Continued

Both Judge Barden and County Clerk Elva Miranda were in agreement on the fact that due to the HAVA compliant requirement mandating political subdivisions to use County polling sites, we were headed towards conducting elections for other political subdivisions in the county.

After discussion, a motion was made by Commissioner Keller and second by Commissioner Mitchell to grant preliminary approval to the contract between Medina County and Devine ISD for the conducting their election, and for the use of Medina County's polling sites. The motion carried unanimously. (See attachment)

# DISCUSS AND CONSIDER ACCEPTANCE AND AWARD OF SEALED BIDS; WIC/HEALTH UNIT RENOVATIONS

Judge Barden reported that two (2) bids had been received. They were from W.R. Griggs Construction Company, Inc. and DeLeon Contracting Co. (See attachment)

After discussion, a motion was made by Commissioner Keller and second by Commissioner Mitchell to postpone this item until the next meeting date. The motion carried unanimously.

#### **ITEM #19**

DISCUSS AND CONSIDER CONFIRMING THE GRANTING OF THE PETITION AND ORDERING ELECTIONS TO CONFIRM THE CREATING OF AND TO AUTHORIZE THE IMPOSITION OF A TAX NOT TO EXCEED THE RATE ALLOWED BY THE TEXAS CONSTITUTION (ARTICLE III, SECTION 48-E) IN EACH OF THE EMERGENCY SERVICE DISTRICTS AS FOLLOWS: A. EMERGENCY SERVICE DISTRICT NO. 2 – DEVINE VFD B. EMERGENCY SERVICE DISTRICT NO. 3 – COMMUNITY EMS C. EMERGENCY SERVICE DISTRICT NO. 4 – DEVINE EMS D. EMERGENCY SERVICE DISTRICT NO. 5 – NATALIA VFD E. EMERGENCY SERVICE DISTRICT NO. 6 – HONDO VFD

Judge Barden stated the required public hearing on the above noted proposed emergency service districts had been conducted, and the petitions had been granted. The next step needed for confirming the district's creation and imposing a tax not to exceed the rate allowed by the Texas Constitution is by placing the issues on the November General Election ballot.

After discussion, a motion was made by Commissioner Keller and second by Commissioner Mitchell to order an election confirming the creation of the above noted emergency service districts, and authorize the imposition of a tax not to exceed the rate allowed by Section 48-e, Article III of the Texas Constitution.

The motion carried unanimously.

# DISCUSS AND CONSIDER AUTHORIZING THE COUNTY CLERK TO SEEK PRECLEARANCE FROM THE DEPARTMENT OF JUSTICE FOR THE ELECTION TO (S.I.C. CONFIRM) CREATE THE FIVE EMERGENCY SERVICE DISTRICTS ENUMERATED IN THE FOREGOING AGENDA ITEM PLUS THE ISSUE OF ANNEXATION OF CERTAIN AREAS INTO EMERGENCY SERVICE DISTRICT NO. 1

Commissioner Keller was appointed to organize this year's entry. The parade is scheduled for Saturday, September 16<sup>th</sup>.

There being no further business to address, the Honorable James Barden, County Judge, declared the meeting adjourned.
