#### ITEM #2

# DISCUSS AND CONSIDER APPROVAL OF JUNE 30, 2006 MINUTES

After review of the minutes, a motion was made by Commissioner Keller and second by Commissioner Carroll to approve the minutes as presented with correction in item 1, add the name Sheriff Gilbert Rodriguez as an official in attendance; and item 14, page 5, add "It was recommended that an outside firm be hired to evaluate the possible replacement of the courthouse air conditioning units. The motion carried unanimously.

#### ITEM #10

# DISCUSS AND CONSIDER FINAL APPROVAL TO MARGAUX COURT SUBDIVISION; LOCATED IN PRECINCT 2 OFF OF COUNTY ROAD 4514 (RICK CROSBY, FLAT ROCK PROPERTIES)

Court members reviewed the proposed final plat of Margaux Court Townhomes Subdivision which consists of 2 lots (Lot 1- 4.412 acres and Lot 2 - 5.180 acres). Also, copies of the covenants and restrictions were presented for the court's review. Each lot in the subdivision will contain 16 town homes. It will also have an extensive greenbelt area.

It was noted that each town home would be owned by the buyer, and surrounding property within the subdivision would be managed by a professional management corporation (homeowners association). Water service will be provided through Ville d'Alsace Subdivision, and the septic systems will be managed by the homeowners association.

Commissioner Keller commented that she previously did have a concern over the drainage problem. However, the issue was addressed and resolved.

After consideration, a motion was made by Commissioner Keller and second by Commissioner Barrientes to grant final approval to the Margaux Court Townhomes Subdivision to include covenants and restrictions. The motion carried.

# ITEM #11

# DISCUSS AND CONSIDER PRELIMINARY AND FINAL APPROVAL TO COUNTY ROAD 777 PRIVATE LANDS SUBDIVISION UNIT II; LOCATED IN PRECINCT 4 OFF OF COUNTY ROAD 777 (JOHN HOWARD, SURVEYOR)

Court members reviewed the proposed plat as submitted. It contains 2 tracts, Tract D-1-4.68 acres and Tract D-2-5.50 acres. It was noted that both tracts have road frontage, and will have water service through Benton City Water Service.

A motion was made by Commissioner Carroll and second by Commissioner Keller to grant preliminary and final approval to County Road 777 Private Lands Subdivision, Unit II, contingent upon receipt of satisfactory letter from Benton City Water Service. The motion carried.

#### ITEM #12

# DISCUSS AND CONSIDER PRELIMINARY APPROVAL TO J. ILTIS SUBDIVISION; LOCATED IN PRECINCT 1 OFF OF FM 2676 (PAUL CAREY, SURVEYOR)

Court members reviewed the proposed preliminary plat which contains 2 lots. Lot 1 consists of 1.50 acres and Lot 2 - 2.08 acres. The eastern portion of both lots are partially located in the flood hazard area. It was noted that an existing home is located on Lot 1, and must be shown on the final plat. Lot 2 is undeveloped. Restrictions on Lot 2 indicate that it can only be used as a residence.

### ITEM #13

# DISCUSS AND CONSIDER USE OF COUNTY ROAD (CR 5711) FOR PIPELINE

Mr. John Hall came before the court and requested that he be allowed to proceed with the laying of a water pipeline across County Road 5711 (LaCoste area) to his property which is located down the road from his homestead. He stated that he had spoken with LaCoste City Administrator Reggie Winters and was told that the City of LaCoste did not have any plans for extending their water lines to cover Mr. Hall's property.

Ms. Karen Seal whose residence is also located on County Road 5711 stated that a County Commissioner or Commissioners' Court cannot give an individual permission to lay pipes down or across a county road. The only time that statutes allow the laying of pipes across a county road is when the property on both sides of the road are owned by the same individual(s). Ms. Seal submitted information for the court's review and commented that she had performed extensive research. She found a Supreme Court case that ordered the removal of a pipeline that was constructed beneath a road. It found that the party laying the pipeline did not own the road. Therefore, it constituted an invasion of a public easement. (It was noted that the Supreme Court case involved a business and not an individual.) (See attachment)

Commissioner Keller stated that she had spoken to legal counsel with the Texas Association of Counties and they could not find anything to prevent the laying of pipelines by individuals.

County Attorney Ralph Bernsen stated that since he does not know how the county acquired the road, he requested additional time to do research and prepare a brief to help the Court with their decision.

County Judge stated that he would notify both parties, and place this item back on the agenda once Mr. Bernsen submits his brief.

Judge Barden stated that a public hearing had been conducted last Thursday evening. Approximately 60-70 persons had been in attendance, with many of those in the audience being in favor of proceeding with the petition.

Dr. Bob Fitzgerald asked if there was any way possible for all proposed emergency service districts to be combined, because he feared the proposed measures will fail when they are placed on the ballot individually. He feels that the people of the county would be in favor of supporting the issue if they were combined, and placed on the ballot as a single issue.

After discussion, a motion was made by Commissioner Carroll and second by Commissioner Keller to grant approval to the petitions for the creation of the emergency service districts and proceed with the next step. The motion carried.

### ITEM #15

# DISCUSS AND CONSIDER PRELIMINARY APPROVAL TO TEXAS VINE ANNUAL MAINTENANCE; FISCAL YEAR 2007

Court members reviewed the proposed renewal maintenance contract for fiscal year 2007 in the amount of \$17,925.

The contract allows crime victim notification service by providing accurate and timely offender information.

It was noted that no revisions to the contract had been made. After consideration, a motion was made by Commissioner Carroll and second by Commissioner Barrientes to grant preliminary approval to the Texas VINE Annual Maintenace Grant Contract for fiscal year 2007. The motion carried.

#### ITEM #16

# DISCUSS AND CONSIDER SERVICE AGREEMENT RENEWAL NOTICE WITH APPRISS, INC., VINE PROGRAM

Court members reviewed the proposed renewal of the service agreement for the administration of the VINE Contract in the amount of \$17,925. (See attachment)

The term of the contract is for one year commencing on September 1, 2006 and terminating on August 31, 2006.

A motion was made by Commissioner Carroll and second by Commissioner Barrientes to approve the service agreement with Appriss, Inc. as outlined. The motion carried.

#### ITEM #17

# DISCUSS AND CONSIDER IMPOSITION OF COUNTY ROAD & BRIDGE FEE AND CHILD SAFETY FUND FEE ON VEHICLE REGISTRATION FOR CALENDAR YEAR 2007 (TRANSPORTATION CODE, SEC'S 502.172 AND 502.173)

After discussion, a motion was made by Commissioner Carroll and second by Commissioner Keller to retain the current \$10.00 County Road and Bridge Fee for each vehicle registered in the county for 2007. The motion carried. (See attachment)

### ITEM #18

### DISCUSS AND CONSIDER BID AWARD; CRUSHED BASE

Judge Barden stated that bids had been received from Vulcan Materials and multiple bids (3) from Medina Crushed Stone. (See attachment)

After review, a motion was made by Commissioner Carroll and second by Commissioner Keller to accept and award the crushed base material bid to both Vulcan and Medina Crushed Stone. The motion carried unanimously.

#### ITEM #19

# DISCUSS AND CONSIDER AUTHORIZATION TO ADVERTISE TIME WARRANT FOR BRIDGE REPLACEMENT; PRECINCT 4

A motion was made by Commissioner Carroll and second by Commissioner Keller to authorize advertisement for a time warrant in the amount of \$206,000 for bridge replacement on County Road 761 and repairing a low water crossing on County Road 731. It was noted that the funds spent on these two (2) projects qualify as matching funds for a \$2,000,000 TxDOT project to replace a bridge on County Road 545 (Biry Bridge). The motion carried.

#### ITEM #20 DISCUSS AND CONSIDER BURN BAN

Court members discussed the possibility of discontinuing the burn ban. Commissioners Carroll and Keller both commented that their precincts had received some rainfall. Commissioner Keller stated that she had been receiving requests to lift the burn ban. Judge Barden commented that not all of the entire county had received rainfall and expressed caution.

After discussion, a motion was made by Commissioner Keller and second by Commissioner Carroll to lift the burn ban in the unincorporated areas of the county and rescind the order dated May 8, 2006. The motion carried. This item is to be placed back on the agenda in two (2) weeks.

Sheriff Rodriguez commented that anyone needing to burn must notify the Sheriff's Office before burning.

Commissioners' Court stressed the importance of using safety precautions and common sense when burning.

Judge Barden asked court members to consider possible dates for conducting budget workshops. After discussion, their 1<sup>st</sup> budget workshop was set for Monday, July 17<sup>th</sup> at 1:30 p.m.
