## Regular Meeting Minutes July 24, 2025

#### 1. CALL TO ORDER AND ESTABLISH QUORUM:

President Leo Rodriguez called the meeting to order at 6:02 p.m. A quorum was present with Commissioners Manuel Rodriguez, Maria Sanchez, and Leonel Garcia.

#### 2. <u>CITIZEN REGONITION AND COMMENTS:</u>

#### 3. SERVICE PROVIDERS REPORTS:

- A. LVFD-No member was present for questions due to fire call.

    MOTION: Commissioner Garcia moved to purchase the 20 sets of SCBA's plus the fee to transfer the compressor to station #3 from the "new equipment / PPE" budget line, second by Commissioner Sanchez, discussion: rather than pay to transfer the outdated compressor and have it retro fitted for the new units, the new compressor should be purchased, MOTION AMENDED: Commissioner Garcia moved to approve purchase of 20 sets of SCBA and a new compressor for the units, second by Commissioner Sanchez, discussion: NVFD will update further on this purchase in August, being no further discussion; motion carried 4/0.

Property tax exemption: EKC informed that because the reserves have not reached 1 (one) year funding, it is not recommended at this time, as an example, due to the flooding, Kerr County lost \$200 Million dollars in property tax revenue and will have to rely on reserve funds to operate. Discussion postponed.

- E. Station #1 new building: Postponed.
- F. Station #3: At 6:44 p.m. President L. Rodriguez called the meeting into closed session under Texas Government Code 551:087 (Economic Development) and reconvened in regular session at 6:56 p.m.
- MOTION: VP Sanchez moved to continue discussion in August on the purchase of property for a third station in the eastern portion of District #5. Second by Commissioner M. Rodriguez, there being no further discussion, motion passed unanimously 4/0.
