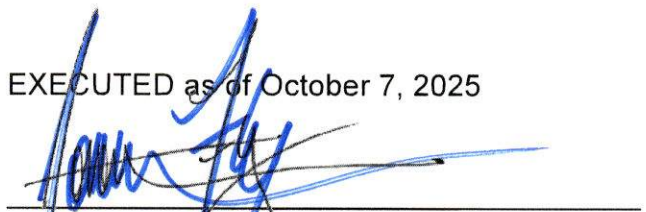
RECITALS

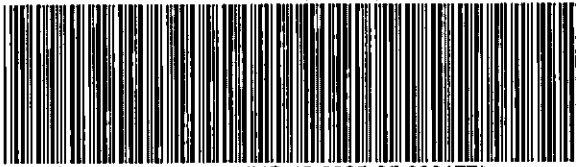

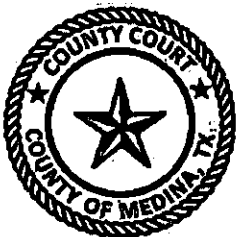
