**5. Property to Be Sold.** The property to be sold is described in the attached Exhibit A.





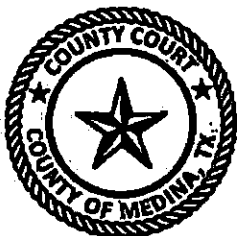
